## WAIVER/ RELEASE OF LIABILITY / DRIVERS DECLARATION

#### **READ THIS CAREFULLY - IT AFFECTS YOUR RIGHTS!**

The undersigned ("Driver") for him/herself, their heirs, assigns and legal representatives, herby expressly agrees to waive, release and covenant the following:

#### **Assumption of Risks**

Assume any and all risks and damages, occurrences, accidents involved in or arising from Driver's use of or presence upon the facilities (especially the track, the Facilities), including without limitation, death, bodily injury or property damage resulting from collision between a vehicle with another vehicle, or a person or a stationary object, skidding, overturning sudden stops, braking or acceleration, fire or explosion, the unavailability of emergency medical care, or the negligent or deliberate act of another person.

#### Release

Release Oman Automobile Association ("OAA") and Al Ain Raceway ("AAR") organisers of the MENA Karting Championship 2020, their parent, subsidiaries, successors or predecessors in interest, assigns, or any related or affiliated entities, franchises, officers, directors, employees, agents representatives, attorneys, insurers, insurance adjusters, insurance agents and brokers (the "Released Parties") from, and AGREES TO WAIVE AND COVENANT NOT TO SUE them on account or in connection with any and all actions, causes of action, claims, demands, injuries, damages, losses, costs, expenses, compensation, rights, debts, liabilities, obligations, disputes, controversies, and payments of every kind and character, known or unknown, existing or contingent, latent or patent, regarding, arising from, on account of, growing out of, or in any way related to, the Driver's/Spectator's or any other third parties use of or presence upon the Facilities, the conduct of the Released Parties, or on Driver's own conduct, whether or not due to the Driver's own negligence, acts, or omissions, or the negligence, acts or omissions of other third parties, or the Released Parties, for any and all known and unknown personal injuries, death, disabilities, damages, or intangible damages occurring at the time hereafter.

#### Waiver

Waiver the protection afforded by any statute or law in any jurisdiction whose purpose, substance and/or effect is to provide that a general release shall not extend to claims, material or otherwise, which the person giving the release does not know or suspect to exist at the time of executing the release. Acknowledgement and agreement that no representation or warranty of any kind or nature whatsoever has been given to the undersigned regarding the condition of any Facilities or equipment. Agreement that the Released Parties shall not be liable for any alleged negligence pertaining to the condition of the Facilities and/or equipment.

Acknowledgement and Agreement that the participation in the MENA Karting Championship 2020 ("MENA KC") is made in full compliance with all Event Regulations and any decisions of the Released Parties (and/or its representatives) and/or the Panel of Stewards of the MENA KC (altogether the "Decision-Makers") will be accepted at all times, hence no legal claims whatsoever will be asserted by the undersigned against the Decision-Makers on the basis of decisions made in accordance with the Event Regulations.

#### Indemnification

Ilndemnify and defend OAA, AAR and the Released Parties against and hold them harmless from any and all claims, demands, actions, causes of action, liability, losses, damages, costs, expenses and reasonable attorneys' fees, which the Released Parties may incur in any way related to the Driver's conduct, Driver's use of or presence upon the Facilities or participation in the MENA KC including without limitation the negligence, if any, of OAA, AAR or the Released Parties.

#### **Payment**

Pay for any and all damages to the Facilities caused by the Driver negligently, willfully or otherwise.

I acknowledge and I understand that engaging in motor sport is a hazardous activity. I voluntarily participate in these activities with knowledge of the danger involved, the risks of serious bodily injury, illness, death, damage or loss to myself, my property and to third parties and their property. I expressly declare and agree to assume the entire risk of any and all damages, occurrences, accidents and personal injury, including but not limited to disability or death, that I may suffer while participating in the MENA KC, whether identified in this waiver to indemnify or not, even if caused in whole or in part by the negligence of the Released Parties:

I acknowledge and agree and grant permission to OAA and AAR to use my name, voice, photograph, likeness, performance taken or recorded at the MENA KC and to reproduce, edit, distribute, perform and publish such for advertising, promotional and other purposes in any media (print, promotional, internet, video, or otherwise) of any kind throughout the world in perpetuity without notice, further consent or payment of any kind. I hereby waive any right that I may have to inspect and/or approve the finished product or the advertising copy that may be used in connection therewith. #### **DEFINITIONS**

- **Agreement -** means the present agreement and its annexes.
- **Commencement Date** the date shown on the signature page of this agreement
- Purpose: Settlement for damages, repair & replacement of all assigned equipment's.
- Terms of Payment: Mode of payment: Cash, Cards or Bank Transfer
- Event Organizer: Oman Automobile Association (OAA)
- Driver/Crew: Equipment's Recipient
- Equipment: This is pertaining to all the equipment's to the designated drivers nominated by the ASN
- **ASN**: Designated Club that drivers belong to as per country of representation

## a) RECITALS: ASN

ASN will be responsible for paying for repairs of Equipment for damages sustained while Driver is operating or in control of the assigned equipment's, whether on or off the track or in the pit or paddock area of the track, if any equipment's is totaled beyond repair or if said repairs exceed the Fair Market Value of said Equipment ASN will pay event organizer the amount equivalent to which it incurred.











ii. Repair Rates: ASN agrees that all labor expenses for repair of the equipment's shall be calculated at a base rate per hour to repair of the equipment's' if such repairs are required because of crash or impact with another competitor

(regardless of fault) misuse. Price of parts and labor expenses shall be paid to

- iii. In the event that ASN shall fail to pay OAA any sums due under this Agreement when due or shall fail in any way to comply with any other term or provision of this Agreement. OAA shall have the right to terminate this Agreement without notice. Upon such termination, all ASN rights hereunder shall be ended and shall remain liable for any damages resulting from their breach, including cost of collection and all reasonable court and attorney fees.
- iv. <u>Driver/ASN</u> acknowledges that he or she is covered by his own adequate medical insurance for any injuries that may be sustained during the term of this agreement, OAA has not and will not provide medical insurance to the Driver, and Driver further agrees not to seek coverage from OAA's insurance policies, if any.
- v. ASN acknowledges that the Driver, Crew nominated / he or she is in suitable good mental and physical health to operate the Equipment's.
- vi. Driver /Crew shall operate the Equipment's in accordance with the accepted on- track rules, regulations and courtesies and safety guidelines.

#### b) **RECITALS: ORGANIZER**

OAA.

- i. Organizer will issue a brand-new Equipment's' with complete chassis, engine and accessories including seat, Kart Trolley, Battery Charger with connector for local electrical network on loan basis to the Driver for the purpose of the event: MENA Karting Championship Nations Cup 2021.
- ii. Prior to driver taking possession, Organizer had already performed a basic inspection and check that the Go-Kart is in generally good mechanical good condition, however the driver and his crew is fully responsible to inspect the Go-Kart prior to use and prior to operation.
- iii. Organizer will provide a set of tires (2 sets) to be used on Practice and on official Race days. Additional requirements are chargeable.
- iv. Organizer may at its sole discretion recall all the equipment's at any time if said equipment's shows evidence of having been subjected to abuse or ontrack conduct is such that damage to the equipment's appears to be a foreseeable likelihood.
- v. Event Organizer will provide Transponder for hire for the full event for OMR 13.











vi. ASN will provide access to driver and crew to Air compressor, Tyre bead breaker and containers with water for tyre leakage test etc.

## c) FEES OF EQUIPMENT, PARTS, SPARE PARTS & REPLACEMENT & REPAIR

- i. ASN Agrees to pay OAA for the total sum according to the extent of the damages, repair and or replacement of the equipment's in case it is beyond repair or Spare Parts etc. assessed by Event Organizer Technical Team.


