

MENA KARTING CHAMPIONSHIP CATEGORIES

The karting disciplines available for drivers at the MENA Karting Championship 2021 are:

- 1) MENA Rotax MAX Challenge *
- 2) MENA RD1 ELITE Endurance
- 3) MENA RD1 ELITE Sprint
- 4) MENA Nations Cup

Maximum Number of Participants: Excerpt from the MENA Cup 2021 Regulations

Each MENA ASN may nominate the following delegates:

- > 1 Driver per Category in MENA RMC Classes (up to 6 Drivers in Total free of charge fully subsidized by the organization) Only MENA Nationals (maximum 8 per country) and MENA residents (maximum 4 per country) will be permitted to compete in MENA RMC categories. (a total of 12 Drivers limit) -- An ASN may add additional drivers beyond the prescribed limit on a firstcome-first-served basis, subject to availability and organiser approval.
 - Note: 1050 OMR contribution for any additional MENA Rotax Max Challenge Entries.
- Up to 2 teams' entries into the MENA RDI Elite Endurance consist of 2-3 drivers (mixed of MENA National & MENA Residents)
 - Note: 210 OMR per additional team entered into the RDI Elite Endurance no limit until slots are full
- Up to 3 drivers in the MENA RD1 Elite Sprint (mixed of MENA National & MENA Residents)
 - Note: 105 OMR per additional driver entered in to the RD1 Elite Sprint no limit until slots are full

- All Fees & Dues are inclusive of VAT (OAA VAT Registration: OM1100014382)
- Payments are non-refundable, this applies even to cancellations and no show.
- In the event of cancellations and no show, entry fee is still applicable.

(1) MENA ROTAX MAX CHALLENGE (RMC)

MENA RMC participation is open to holders of either a Kart National or Kart International License and Kart Residents issued by the ASN of a MENA country. Drivers should be nominated by their ASN.

All Rotax MAX categories are available (Micro MAX, Mini MAX Junior MAX, Senior MAX and DD2 and DD2 Master), covering all age ranges from Byrs and upwards.

Participation is open to MENA Nationals & MENA Residents (delegates must hold an original passport issued by the MENA country they are representing & MENA Residents has to provide proof of Residency).

With limited spaces available, entries will be accepted on a first-come-first-served basis.

Drivers will collect their racing equipment on Tuesday 16th November 2021. Two practice days will follow (Wednesday & Thursday) with the official Welcome Ceremony taking place at 1800hrs on Thursday 18th November 2021.

Friday 19th November 2021 consists of Timed Qualifying and three Qualifying Heat races with Pre- Final and Grand Final taking place on Saturday 20th November 2021 ahead of the official Awards Presentation.

(2) MENA RDI ELITE ENDURANCE (TEAM COMPETITION)

This is a team format for both license-holders and non-license holders. Participants can be MENA Nationals or residents and will be nominated by their respective MENA ASN.

Drivers must be a minimum of 15 years of age and a minimum weight of 55kg.

Karting (or motorsport) experience is required as the karts are of premium performance.

RDI ELITE karts will be made available on both Wednesday 17th and Thursday 18th November 2021 according to demand. These practice sessions are optional and can be booked and paid for separately.

Participants must be present for the official Welcome Ceremony on Thursday 18th November 2021 at 1800hrs.

The MENA RDI ELITE ENDURANCE will be incorporated into Race Day 1 on Friday 19th November 2021 and will consist of:

- Registration and weighing
- Driver and Team Briefing
- Practice/Qualifying session (20 mins approx.)
- 2 HR Endurance Race

The number of drivers per team can be 2 or 3. Team helpers/support crew is open and at the discretion of each team.

All team drivers will be required to complete practice laps during the allotted practice window.











Start positions for the Endurance race will be decided by the best lap times achieved during the practice session.

The Endurance race will be run over a fixed 2-hour period with teams having to manage driver changes and fuel stops throughout this time, implementing a strategy so as to maximize the driving distance over the race duration. The final result will be based on the total number of laps completed by each team within that period.

Teams will be ranked according to finishing positions with the top 3 teams receiving trophies at the Awards Presentation on Saturday 20th November 2021.

All MENA teams will gain Nations Cup Ranking points for their country. Regulations will be properly drafted and communicated ahead of time.

The maximum number of teams is 20. Entries will be accepted on a first-come-first-served basis.

(3) MENA RDI ELITE SPRINT (INDIVIDUAL)

This is an individual format for both licence-holders and non-licence holders. Participants can be MENA Nationals or residents and will be nominated by their respective MENA ASN.

Drivers must be a minimum of 15 years of age and a minimum weight of 55kg.

Karting (or motorsport) experience is required as the karts are of premium performance.

RDI ELITE karts will be made available on both Wednesday 17th and Thursday 18th November 2021 according to demand. These practice sessions are optional and can be booked and paid for separately.

Participants must be present for the official Welcome Ceremony on Thursday 18th November 2021 at 1800hrs.

The MENA RDI ELITE SPRINT will be incorporated into the Race Day 2 on Saturday 20th November 2021 and will consist of:

- Registration and weighing
- Driver Briefina
- Practice session (10 mins approx.)
- Qualifying session (10 mins approx.)
- RD1 ELITE Sprint Pre-Final (15 mins approx.)
- RDI ELITE Sprint Final (20 mins approx.)

Practice is timed but non-competitive while qualifying will be against the clock with the fastest lap securing Pole Position for the Pre-Final race.

Drivers will start their first pre-Final race in the order of their Qualifying ranking and the finishing order of this race will determine start positions for the Final.

The longest Final race will determine the overall RD1 ELITE Sprint rankings with the top 3 drivers receiving trophies at the Awards Presentation, Drivers will also accumulate Nations Cup points for their country throughout the competition.

Regulations will be properly drafted and communicated ahead of time. Entries will be accepted on a first-come-first-served basis.















(4) MENA KARTING CHAMPIONSHIP - NATIONS CUP

MENA drivers in all categories will contribute to their 'Nations Cup' or Country ranking.

Points scored in each of the disciplines will be recorded and accumulated to make an ultimate MENA Karting Championship Nations Cup Total.

The top 3 MENA Nations will be rewarded with trophies at the Awards Presentation on Saturday 20th Novemberh 2021 with the overall winner declared as the MENA Nations Cup Champion 2021!

IMPORTANT: REQUIRED REGISTRATION DOCUMENTS

MENA ROTAX MAX CHALLENGE CATEGORIES

KART COMPETITION LICENSE [MANDATORY]

Competitors must be in possession of a valid National or International license issued by their National Sporting Authority (ASN). A clear copy must be sent with the Entry Form as part of the pre-registration. The ORIGINAL license must be presented to the registration office on site.



B) ENTRANT LICENSE [*DPTIDNAL*]

A national/international entrant license can be issued by your National Sporting Authority (ASN). If used, a copy must be sent with the Entry Form as part of the pre-registration and the original must be presented to the registration office on site.



C) STARTING PERMISSION

Competitors with licenses issued outside of Oman must obtain an official Starting Permission signed and stamped by their National Sporting Authority (ASN). A copy must be sent with the Entry Form as part of the event pre-registration. It has to be brought as an original to the registration office on site and send the copy by email in advance before the event to maridel@omanauto.org.



ORIGINAL PASSPORT

A clear copy of the competitor's passport must be sent with the Entry Form as part of the pre-registration. The original passport must be presented to the registration office on site.



DRIVER PHOTO

A clear passport-sized photo of the competitor must be sent along with the Entry Form as part of preregistration.



VALID PROOF OF RESIDENCY FOR NON-MENA NATIONAL (MENA RESIDENTS)

A clear copy of the competitor's National ID or resident cards. A copy of this must be sent with the Entry Form as part of the pre-registration. The original must be presented to the registration office on site.



G) PARENTAL AUTHORISATION FORM

Drivers must hold a valid national license, issued by their national karting federation.

125 JUNIOR MAX

Drivers must hold a *valid national or international license* grade C Junior, issued by their national karting federation.

125 SENIOR MAX

Drivers must hold a valid national or international license grade C Restricted or international license grade C Senior, issued by their national karting federation.

125 MAX DD2 / 125 MAX DD2 MASTER**

Drivers must hold a valid national or international license grade C Senior, issued by their national karting federation.











**The MENA Karting Championship considers DD2 as one category only. Of course, ASNs should feel free to nominate drivers that are of 'Masters' age but they will be ranked as DD2 overall rather than having a separate classification.

RETURN OF EQUIPMENT AT THE END OF THE EVENT

All equipment provided for the event on a loan basis must be returned in appropriate and clean condition (except used tyres).

Chassis with engine, trolley, battery charger and optional gear ratios must be returned according to the "Return Instruction" of the organiser.

Radiator must be drained from water.

Carburetor must be drained from fuel. - Please use the designated fuel containers (marked) located in the parc fermé and to empty the carburetor.

NOTE:

For any item which has been provided on a loan basis for the duration of the event and which is not returned as requested or which has been damaged during the loan period, the driver will be charged the corresponding fee. The driver is responsible for all damages caused by any race accident.

The distribution and return of the equipment are defined in the official event schedule.

PERSONAL EQUIPMENT PROVIDED BY THE DRIVER

- Personal race gear, race suit (preferably in the respective country colours), helmet, race boots and gloves must comply with actual FIA Karting Technical Regulations requirements (see FIA Karting Technical Regulations, item 3.2 Equipment Safety).
- Personal transponder with mounting bracket. The transponder ID is required for registration. The mounting position is defined in the event regulations.
 - The driver is responsible for the timely charging of the transponder to assure a faultless function during the event.
 - Transponders are available for hire in limited numbers on a first-come-first-served basis from the organization. Hire fee is OMR 13 for the entire event. The driver/entrant is liable for the full cost of the transponder (total OMR 210) in the event of any loss or damage sustained during the hire period.





- Personal data acquisition system (data logger with sensors)
- Personal tyre pressure gauge
- Basic tools to carry out general kart maintenance work and also specialized tools (e.g. wheel alignment gauge, fixation tool for the starter gear, etc.).

- Floor Mats (or suitable equivalent floor covering) beneath karts when work is being carried out is mandatory throughout practice and race days.

EQUIPMENT - MENA RD1 ELITE COMPETITORS

WHAT WILL BE PROVIDED FOR THE EVENT?

RDI ELITE karts will be provided for both Endurance (Friday 19th November 2021 and Sprint (Saturday 20th November 2021) formats.

These karts have been specifically designed to cope with the rigours of high performance endurance kart racing in the Gulf region and are identically prepared.

The one-of-a-kind chassis, codenamed RD1 XR DD2, features adjustable pedals and adjustable seat while the powertrain utilises a water-cooled Rotax 125 MAX EVD hybrid engine with chainless drive, generating 24hp in unrestricted form.

The RDI ELITE karts are fitted with steering-wheel-mounted MyChron 5 data-loggers which provide drivers with an up-to-date digital display of lap time, engine speed and water temperature.





PERSONAL EQUIPMENT PROVIDED BY THE DRIVER

- Personal race gear, race suit (preferably in the respective country colours), helmet, race boots and gloves. Ideally these will comply with FIA Karting Technical Regulations.
- Support crew (optional) to assist with endurance race strategy and format

Muscat Speedway is a world class karting facility located in the heart and capital of Oman, Muscat. The facility's history dates back to 1979 and the track itself has undergone significant maintenance and development in recent times to bring it up to latest safety standards.



Muscat Speedway currently hosts different categories of races and endurance championships

The picturesque International Circuit configuration is the venue's longest layout at 1,153 metres and includes multiple elevation changes and a mixture of slow and fast corners to test the drivers.

Country Information

State name: The Sultanate of Oman

Capital: Muscat

Climate: The Climate of Oman can be described as subtropical dry, hot desert climate with low annual rainfall, very high temperatures in summer and a big difference between maximum and minimum temperatures, especially in the inland areas.

Summer (June to September) is very low rainfall. Daily maximum temperatures can reach easily 40° C or more. Winter is cooler with occasional rainfall. Spring and autumn are warm, mostly dry and pleasant, with maximum temperatures between 25°C and 35°C and cooler **night Temperatures** between 15 and 22°C.

A hot, dust-laden wind, the Shamal, blows in the spring and summer-period, from March till August, Sometimes these winds can be very **strong**, and cause Sandstorms, that can occur throughout the year. Most rain falls during the winter months in sudden, short but heavy cloudbursts and thunderstorms.

Currency: Omani Rial

Electricity: The standard voltage is 240 V and the standard frequency is 50 Hz. In Oman the power plugs and sockets are of type G. If the standard voltage in your country is in between 220 - 240 V (as is in the UK, Europe, Australia and most of Asia and Africa) you can use your electric appliances in Oman. If the standard voltage in your country is in the range of 100 V - 127 V (as is in the US, Canada and most South American countries), you need a voltage converter in Oman. You can also consider a combined power plug adapter/voltage converter.

Things to know: Muslims are forbidden to drink alcohol, but most of the hotel bars and restaurants have a bar for guests. Visitors are only allowed to drink alcohol if they purchase drinks from licensed hotels and restaurants.

INTERNET & MOBILE NETWORKS

Omantel. Ooredoo and reseller Renna all have 24-hour booths in the arrivals hall at Muscat International Airport, making it easy to buy a SIM card even before you've set foot in the country. To sign up, you'll need passport.













EAT & DRINK

Oman has a long history as a state and through its history has made a great contribution to civilization. At one time Oman was an influential seafaring nation whose foreign relationships extended as far as China, the USA, Britain and France. Omani ambassadors have been presenting their credentials in the capital cities of these countries for about 200 years.

The cuisine of Oman recalls its role as a key trading post between east and west. Muscat is the dining centre of Oman and the best places to try some of the more interesting dishes of the Sultanate. including spectacular seafood hauled fresh from the Arabian Sea. Some of the tastiest dishes are reserved for big religious festivals. Local eschew alcohol in favour of strong coffee, flavoured with cardamom and served with dates and other sweet treats.

WHAT TO SEE

The Sultanate of Oman is a country of breath-taking natural beauty. As the oldest independent state in the Arab World, it has embraced modernization and progress while retaining the core aspects of its culture and heritage - making it the perfect travel destination for those seeking an authentic Arabian experience.

Muscat is the modern capital of Oman and offers visitors a stunning combination of old and new. From the architectural masterpiece that is the Sultan Qaboos Grand Mosque, to its mountain backdrop and breath-taking beaches, this city never fails to entertain and inspire.

There are five UNESCO heritage sites in Oman that, all of which are worth visiting.

Bahla Fort was inscribed as World Heritage Site in 1987 and has since been beautifully restored. The fort reopened to the public in late 2012.

Credited to the Bronze Age (3rd millennium B.C.), the archaeological sites of Bat, Al Khutm and Al Ayn in Ad Dhahirah make up the world's most complete collection of beehive tombs.

In Dhofar, the Land of Frankincense encompasses the frankincense trees of Wadi Dawkah Reserve and the remains of caravan and trading settlements such as Ubar, Khawr Ruri and Al Baleed - highlighting the importance of frankincense for the flourishing trade in the region during ancient times.

This ancient watering method is deeply rooted in Oman's heritage, with over 3000 aflaj – or irrigation systems – still in use today. Using gravity to transport water from springs, the fair management of these waterways plays an important role in communities around the country. Falaj Daris in Nizwa, one of Oman's longest falaj, is still in use today.

The Ancient city of Qalhat in Sur. This site has an exceptional international value for trading between Oman and the ancient world civilizations. It's considered as a distinctive example of the architecture and planning of active port cities in the middle ages.























HOW TO GET THERE

Oman is just seven hours direct flight from many European and Asian cities, and connected to North and South America. Austratia and Africa by direct flights or short transfers from neiahbourina Gulf States.

There are three Airports; which are: Khaseab Airport, Muscat International Airport and Salalah Airport.



Oman Air is the national carrier of the Sultanate and is based at Muscat International Airport. In addition, there are several airlines that operate direct flights to Oman on a daily basis.

Distance of the race track to Muscat International Airport:

Upon arrival in Muscat International Airport, approximately 13.6 km or 14mins travel time. Car rental is an easily accessible option to benefit the maximum from your stay in the country: Taxis are also available.

DRIVING IN OMAN



Driving is on the right side of the road.

Traffic signs in Oman are typical, nothing drastically different. The traffic laws in Oman are comprehensive and strictly imposed. Speed cameras are placed every 1.2 miles (2km) in Muscat. Speed is measured in km/h, and signs are according to the ISO (European) system. Some basic pointers and considerations to think about when driving in Oman: The speed limits are 120km/h on motorways, 90km/h on open roads and between 40km/h and 80km/h in cities/urban places.

The numbers are in dual language with Arabic numbers at the top within the same sign. There is zero tolerance for driving while inebriated. It is illegal to use your phone while driving. Beware of stray animals on the road - roque camels, random goats, etc.

In order to rent a car in Oman, you must have an international driving license. In addition, you will need to present an additional form of identification such as your passport. The minimum age for renting a car in Oman is 21, although this varies from one company to another and some rental companies set their minimum age as 25. You must have had your license for at least one year before being permitted to drive in Oman.











ENTRY INFORMATION / VISA

Oman is situated in the southeastern part of the Arabian Peninsula. It is surrounded by the sea on two sides, the sea of Oman to the northeast and the Indian Ocean to the southeast; it has joint land borders with Saudi Arabia to the west. Yemen to the south. and the United Arab Emirates to the north.

You must have an Oman visa to travel to Oman unless you come from a visa-exempt country. If you are the citizen of a member state of the Gulf Cooperation Council (GCC), you may visit Oman even without a visa. You need a valid passport with at least six months' validity from your intended arrival date.

- All Omani citizens, residents of Oman, visa holders of Oman, those who do not require a visa to travel to Oman, and those who can obtain a visa upon arrival are allowed to enter the Sultanate in accordance with the pre-COVID-19 system.
- 2. Institutional quarantine will continue to be applied, until further notice, to all arrivals from the Republic of Iraq and the Islamic Republic of Iran, including Omani citizens arriving from the aforementioned two countries.
- 3. All passengers arriving to the Sultanate are required to present a COVID-19 vaccine certificate containing a QR Code stating that they have received two doses of any COVID-19 vaccine approved in Oman Pfizer BioNTech, Oxford AstraZeneca, Covishield AstraZeneca, Sputnik, Sinovac, Moderna, and Sinopharm, or a single dose of Johnson & Johnson. The last dose is required to have been received not less than fourteen (14) days ahead of estimated arrival time. The Ministry of Health publishes and updates the list of vaccines approved in Oman.

- 5. All passengers arriving to the Sultanate without holding a negative COVID-19 PCR test in accordance with paragraph number (4) of this circular are subject to a COVID-19 PCR test upon arrival where after the traveler shall be required to enter mandatory quarantine with electronic tracking bracelet until a negative PCR test result is received. However, in cases of a positive PCR test result, the passenger shall be required to undergo mandatory health isolation for ten (10) days starting from the test date. Except that passengers who have recovered from COVID-19 but tested positive on arrival are exempted from health isolation providing they are able to submit proof that they have completed the prescribed isolation period in the country where they were infected before traveling to the Sultanate.
- 6. Before boarding the aircraft, all passengers arriving to the Sultanate, are required to complete pre-registration via (https://covid19.emushrif.om/) and to upload the vaccine certificate as well as the COVID-19 PCR certificate, both containing QR Codes. If the passenger prefers to conduct the COVID-19 PCR test upon arrival, the passenger shall pay the

Omani citizens and their families and non-Omanis working in the Sultanate in public or private units and with valid residency who are not vaccinated in accordance with item (3) of this circular are allowed to return to the Sultanate and subject to the health requirements issued before 1st of September 2021.
- 10. Diplomats working in the foreign diplomatic missions accredited to the Sultanate and visitor diplomats are exempted from the registration in (<u>https://covid19.emushrif.om/</u>) and from the COVID-19 PCR test.
- 11. Aircrews are subject to the precautionary measures for COVID-19 issued by the Ministry of Health.
- 12. This decision is effective from today Wednesday, 01st September 2021.
